1 INCREASE IN MEMBERSHIP



The number of "life members" has increased by **332** new members during the financial year 2024-25.

The total number of life members has increased to **1,40,805** as on 31st March 2025 from **1,40,473** at the end of the previous year 2023-24.



Efforts have been made to increase the membership of the fund and to augment more contribution for the fund by advertising the special drive scheme for augmentation of fund in CA Journal in every alternative month and standard appeal as a part of every mail issued by the CPE/POUs for their programs along with the link of CABF for voluntary contribution by the members.

3 COLLECTION OF FUND



During the year, a sum of **Rs. 1,08,75,769** was received as voluntary contribution from the members as compared to **Rs. 67,91,163** in the previous year.



During the year 2024-2025 a sum of **Rs. 2,35,97,137** was collected in the Corpus of the Fund in comparison to **Rs. 32,35,000** during year of 2023-2024.



The balance to the credit of General Fund at the close of the year stood at **Rs. 1,21,95,239** as against **Rs. 68,99,517** at the end of the previous year.



FINANCIAL POSITION OF THE FUND



The year closed with a Surplus of **Rs. 52,95,723**.



The addition to the corpus of the Fund during the year was **Rs. 2,35,97,137/-**.



The balance to the credit of corpus Fund is **Rs. 22,00,59,285** as against **Rs. 19,64,62,148** at the end of the previous year.
